



Client Consignment Agreement

("You") and DoubleTake Consignment Boutique ("DoubleTake") hereby agree:

You appoint DoubleTake to be your agent to sell your used, "nearly new" and new designer clothing and accessories. This is known as "consignment for sale." DoubleTake will offer your clothing and/or accessories for sale at a competitive resale market price, which DoubleTake alone, in its sole discretion, will determine.

When you deliver used, "nearly new" designer clothing and/or accessories in saleable condition, DoubleTake will provide you with a written receipt. The receipt will identify the number and type of items to be consigned to DoubleTake, and the 30, 60, or 90 day "expiration date" when the items will be taken off the sales floor. DoubleTake may at anytime reject an item which is not in saleable condition. The DoubleTake sales price will be marked down by twenty-five percent (25%) every thirty days.

The DoubleTake sales price may also be marked down twenty percent (20%) to fifty percent (50%) at any time to promote the item's sale. You may take back any item before it is sold or before the expiration date, after giving forty-eight (48) hours notice to DoubleTake. Any unsold items which you do not request by the expiration date will become DoubleTake's sole property.

DoubleTake will pay you fifty percent (50%) of the selling price, from which it will deduct any reasonable fees, repair, cleaning, or authentication charges which DoubleTake, alone, in its sole discretion, decides are necessary.

DoubleTake will pay you when the total of all items sold by DoubleTake during the previous month is at least fifty dollars (\$50.00). A service charge of \$1.00 will be imposed for payment by mail. A fee will be imposed for the reissue of a check for any reason, equal to the current bank cancellation fee or \$25.

DoubleTake proudly sells only authentic designer merchandise. By leaving merchandise for consignment, you guarantee its authenticity. Should an item be deemed inauthentic or such dispute arise, DoubleTake reserves the right to place a hold on any outstanding account balance(s) and/or confiscate counterfeit goods.

DoubleTake, its officers, directors and employees will not be responsible for loss or damage to or destruction of any consigned item by any cause or for any reason. You agree to release and give up any and all claims and rights against DoubleTake which result from or have to do with the loss, damage or destruction of any consigned merchandise. You agree to take any and all risk of loss, damage or destruction of your consigned merchandise by any cause or for any reason and indemnify DoubleTake against liability without limitation. You agree to purchase any insurance you feel is necessary to protect against these risks.

This is the only and then entire agreement between you and DoubleTake. This Agreement cannot be changed or added to unless the changes or additions are in writing and signed by DoubleTake and you. This Agreement shall be interpreted according to the laws of the State of New Jersey.
